## Report Sexual Assault 1 October 2024

On the evening of January 25<sup>th</sup>, 2024, Donald Watson, arrived in Port Moresby, He invited me (Helen Tuakara for dinner at his apartment office so we can discuss work.

At 8.30 pm I prepared myself to leave his office when he insisted for me to join him to drink whisky, I said I would have a glass and leave after 1 glass as it was about 8.30pm and I needed to get home, Cos we had to work the next day,

Donald was pouring drinks for me until I felt dizzy, and I was unable to walk properly. He said to wash myself and I will feel better to drive home. Without thinking of anything I walked to his bathroom and undressed myself and had a full bath without realizing he was standing at my back watching me, when I realized I had to half bath rush for the towel and got dressed and I told him am so embarrassed that you were watching me, please this is not good.

He blocked me at the bathroom holding my hands and he insisted it was ok. I kept saying this was very bad thing for him to do.

He said that it is OK, and did you know you have a beautiful body?

I kept trying to push him off me to walk out to the living room table getting my stuff and requested to leave.

He responded everything is OK Helen you can leave once you feel better.

He insisted I stay and forcefully pulled me down onto the lounge chair and he was undressing me again.

He was taking my clothes off from my t-shirt to bra and my pants. I told him to stop but he kept touching my private female part and putting his fingers inside me.

He was kissing me and touching my breast and down to tummy beyond to my private parts, taking my Jeans, and under pants off without my consent or permission.

I was trying to push him away continuously and telling him to stop but he was so strong.

I was helpless, he kept telling me I like you; I was helpless from struggling from stopping him.

I eventually fell asleep and when I woke up, I realized I was in his bedroom naked. I only remembered I was outside on the chair so not sure how he got me in the bedroom.

I woke up quickly, I was completely naked and put my clothes on and ran out of his room asking what happened, how come I was in your bed, what did you do to me?

He responded. Helen you where drank so I let you rest; we will talk later. With that he opened my door, and I rushed home it was 5.30am in the morning.

After this I have been so disgusted about everything and told him, I was drinking the night, and he did things to me that I couldn't stop him.

I told him this will never happen again etc.

After that date till today I keep avoiding him cos I was scared he would repeat his sick actions etc.

He has been inviting me for lunch or dinner I was always rejecting his offer. Till today he has put a tracking device to my car and have been micromanaging my job etc, every day and monitoring my movements after work.

Lately he sent the AK staff to get the car off me the reason been my car sitting in one location for 3x hour's.

Seriously this is an insult treating me like a criminal and questioning me of stuff my private life and deprivation of my freedom.

Today I would like for criminal charges to be laid against Donald Watson for raping me with his fingers and touching my body and private parts without my permission or
